Requirements for Membership:

- 🐾 At the next General Membership meeting, the applicant will be voted upon by secret ballot.
- 🐾 New members must be approved by a majority vote of members present at a general meeting.

Regular Membership:

Members eighteen (18) years and older who enjoy all the rights and benefits of the Club. Dues \$20.00 per person, per year. Dues are not pro-rated.

Associate Membership:

Members who are inactive (due to health or distance from Omaha) yet desire to retain association with NKC. Associate members cannot vote or hold office but are eligible for all other Club benefits and privileges. Dues \$20.00 per person, per year. Dues are not pro-rated.

Junior Membership:

Members less than eighteen (18) years of age who enjoy all the rights and benefits of the Club except the right to vote and hold office. No dues are required.
