The Nebraska Kennel Club will present the American Kennel Club's Responsible Dog Ownership Day from 10:00 a.m. to 4:00 p.m. at the Companion Dog Club, 10803 N. 72nd St. (1.5 miles N of 680)

A special feature of the day will be the AKC's My Dog Can Do That, which allows the public to bring their dogs for a training experience. Trainers will *show* you how to get your dog started in the exciting sport of Agility, which is an obstacle course for dogs, and Rally, a fun way to connect with your dogs through basic obedience training. They also will have information on the club's dog training classes.

In addition, you can enjoy numerous demonstrations of trained dogs in action in Flyball, Tracking, Earth Dog, Field Trial work and more. A police dog demonstration is also planned.

There is no admission to attend the Responsible Dog Ownership Day, but there is a fee of \$5 per dog for My Dog Can Do That! (Agility and Rally trial runs) No pre-registration is required – just drop by any time between noon to 4:00 p.m. and sign up at the My Dog Can Do That! ring. Participating dogs must be at least 4 months old and have proof of rabies vaccination. All dogs must be on leash at all times, and no prong collars are allowed. Youth under 18 are welcome to participate but must have an accompanying adult.

Discount registrations also will be offered in the American Kennel Club's Canine Partners program – for all dogs, including mixed-breeds and rescues.


