# Therapy Dogs Help Relieve Stress of the US Olympic Swim Trials

From June 26 through July 2, 2016, USA Swimming held their Olympic swim trials at the CenturyLink in Omaha, NE. Approximately 1,800 swimmers from across the country participated in the special event. Needless to say, stress levels are high for everyone involved, but especially high for the competitors. To help relieve some of this stress, USA Swimming asked some local therapy dogs to come to the trials to provide some stress relief for the swimmers. This was the first time ever, therapy dogs were part of any Olympic Trials.

Two NKC members and their dogs, Shelly Rehmeier and her Black Labrador Retriever, Mari and Sue Volkmer and her Bouvier des Flandres, Zane, were part of a group of 30 dogs and their handlers from Domesti-PUPS therapy group to participate in this groundbreaking event.

The dogs were a hit with everyone from the public to the security guards to coaches who stopped us as we made our way to the Athletes Lounge. But, most importantly, with the dogs were a huge hit with the swimmers. Each day from 10 am to 1 pm and again from 5 pm to 8 pm a group of 4 dogs and handlers got to hang out in the Athletes Lounge. No coaches or media were allowed in the lounge.

The dogs and handlers sat on the floor and welcomed the swimmers to stop by and pet the dogs and chat. It didn't take long for the news to spread "there were dogs in the house." During the three hour sessions, each dog was rarely without at least four swimmers, and at times, six or more swimmers surrounding them, taking photos of them, hugging them, and talking to them. One of the coolest things, according to the swimmers, was that each dog had its own credential, complete with photograph. The dogs' credentials were photographed almost as much as the dogs themselves.



This event was a wonderful experience for both the teams and the dogs. It was really fun to sit with the swimmers and talk about hopes, dreams, and yes, even their own dogs, which they missed because of the competition. Hopefully, we provided them some fun and happy moments in a week of stress.
