## 2018 NKC Tracking Test

he Nebraska Kennel Club held their tracking test November 11, 2018, at Chalco Hills Recreation Area in Omaha, NE.

Our judges were Jane Jonas and Inge Suchanek who did a fabulous job plotting tracks even though the temperature on plotting day was in the 20's and a brutal wind. Test day was much better with a little warmer temperature and less wind. We did get a little snow on Friday before the test.

The test filled with 2 TD's, 5 TDX's and 6 TDX Alternates.

TD Track 1 Was a Wirehaired Pointing Griffon. This team was fabulous to watch as they made it to the glove and PASSED! CONGRATULATIONS! Aux Lake Muzzle Tuff. Owned by Douglas Reimann and Ruth Vogel. Handled by Doug Reimann.

TD Track 2 Was a Golden Retriever. This dog was lovely as she made her way down the track with her coat flying in the breeze.
