This special meeting was called by the President for the Board to discuss a letter and invoice that was sent to Barb Hill from the Lancaster Event Center that discusses that there will be no refunds for our cancelled Conformation event that we had scheduled in May 2020 due to financial constraints that the event center is having from the hardships due to COVID. The total invoice is listed at \$2152.50. The original contract was for NKC to split this with the Platte Valley Kennel Club.

Motion to pay half of the invoice for \$1,076.25 made by Barb Hill. 2nd by Joe Bradley. Board voted: 5-yes votes, 1-abstain vote. Approved, motion carried.

#### **AKC Delegate's Report**

All breed clubs all over the country have the same concerns as NKC. How to proceed and what guidelines to follow, etc. AKC strongly suggests all clubs follow all state guidelines and regulations. Clubs are concerned as to who is to enforce such guidelines. There is consideration for bringing local shows back to communities. Face shields and masks are acceptable for judges and volunteers. Electronic voting remains a possibility depending on local regulations. I still have not found an answer to Nebraska laws but still checking on it. Clubs are concerned about the legal liability protection included in each club policy. AKC continues to hope all clubs will follow Best Practices found on its website. No new wording available yet for clubs to consider for Constitution in regard to the virus, meetings, and voting.

11,000 shows were cancelled due to corona virus. Performance events are slowing opening up again. Entries pretty good although some have withdrawn entries as virus continues to be a problem. Litter registrations have increased as have individual registrations. (I suspect with quarantines that paperwork is being tended to!) Expenses for AKC are down but so is the income. Education continues to be viewed on AKC webinars. Mr. Phillips reported that investments down but overall, the Market has been good for AKC investments. Several amendments pertaining to dog show were read but will not be voted on till the next meeting. Future decisions regarding Delegate and Committee meets are under investigation. AKC Virtual Dog Show was a big success!
