The NKC Constitution requires staggered two year terms. This year, candidates will be nominated for Vice-President, Treasurer, two Board positions, and AKC Delegate.

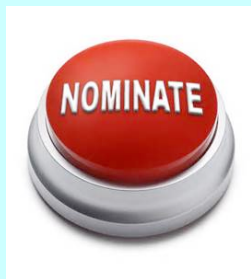

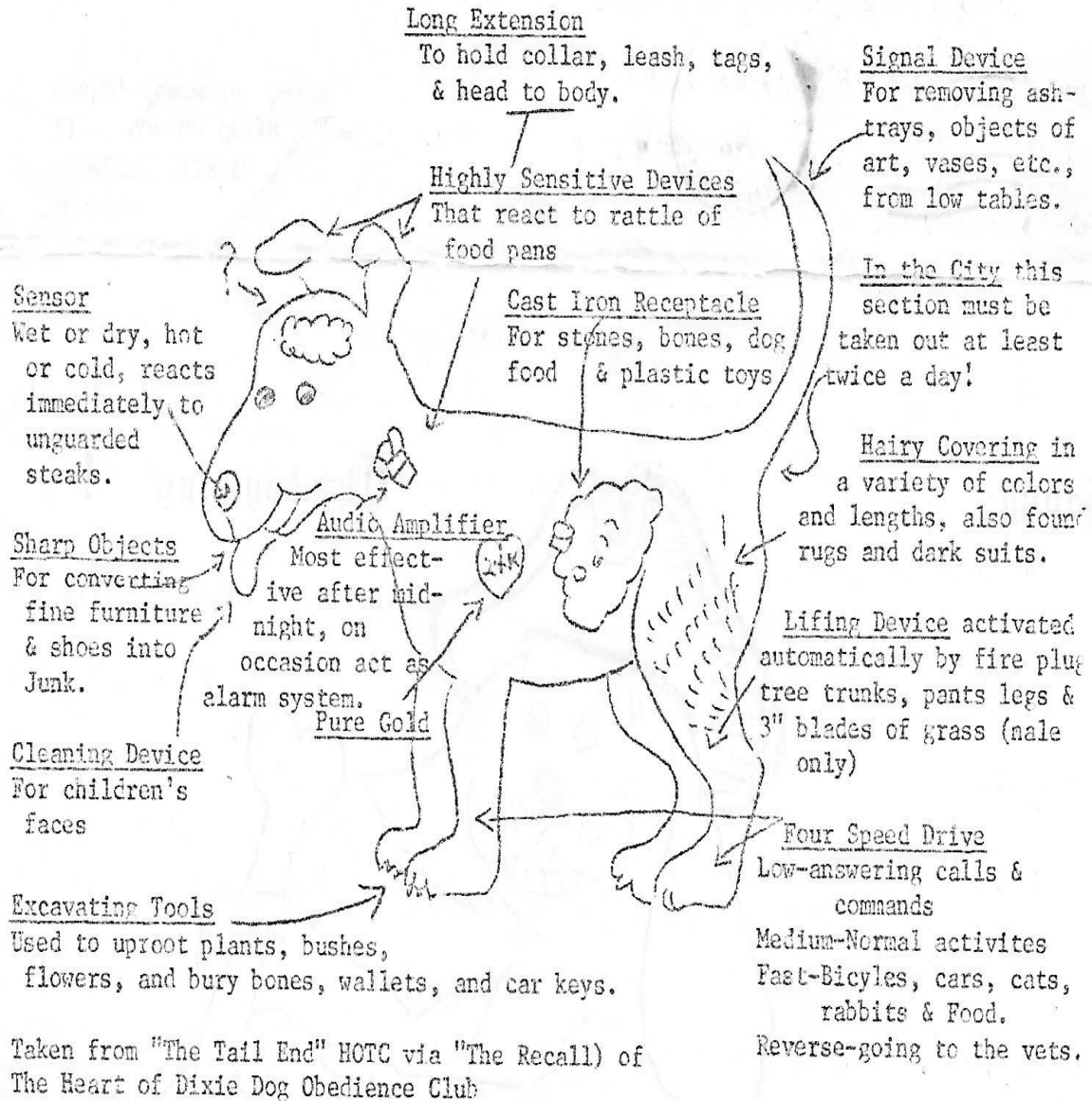
