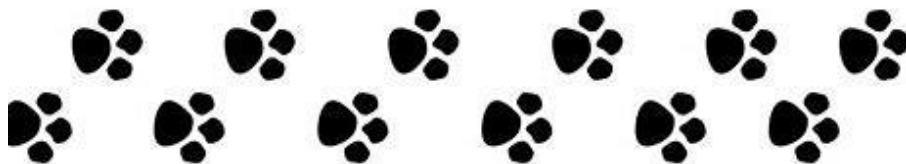

## TROPHY ROOM



The 2023 AKC National Tracking Invitational was held this past weekend, September 9 & 10, 2023 at Branched Oak State Recreation Area in Raymond, NE, jointly sponsored by the Nebraska Kennel Club and the Cornhusker Kennel Club of Lincoln. All of the dogs who have earned the AKC Tracking Championship in the past 10 years were invited to attend. I entered both of my Tracking Champions, GCH CT Snowflower Tarragon CD PCD BN RN PT CGC “Nico” and his daughter CH CT Blackfyre Tarragon Optical Illusion TDU HT BCT “Lexy”. 48 entries were received with only 12 being able to participate, and my Lexy was drawn #5 of those 12. She would be tracking on Saturday, September 9th. I fretted about the weather for the 2 weeks leading up to this weekend, watching the high temperature bounce from 90’s to 100 to upper 80’s, finally settling on a sunny high of 86. That morning I was disappointed to draw Track #6, meaning we would have the last track of the day in the hottest part of the day. But I should have known my dog would carry me, as she always has. The start of her track was in tall heavy cover, the first turn was in still in the tall cover, the next turn went into a meadow alongside woods (and found a metal article, a metal switchplate), then it got interesting. We turned left and went through some bushes and pine trees, and ended up on the edge of a ravine (which our judges Jeanne Ramirez and Inge Suchanek diplomatically called a ‘drop off’). I didn’t see how we could even walk down there, so I backed up and tried to see if Lexy would turn and go a different way. She wouldn’t, so we backed up and she went down the ‘drop-off’. Then we went 90 yards winding along the side of the ravine in unstable footing, finally turning and going up out of the ravine to a short mown picnic area (and found the plastic article, a plastic switchplate cover). The track went into the picnic area and under a tree, where my very hot and tired dog decided she needed a break and laid down under the tree, panting hard. Because of the weather forecast I had packed a small cooler with ice and cold towels and extra water, and with the judges’ permission my good friend Mary Kramer carried the cooler in the gallery in case of heat distress. I asked the judges if Mary could bring me the cooler, and they agreed. After several minutes of cooling Lexy, Mary backed up back into the gallery and I coaxed Lexy to continue. It turned out she had laid down right on the last turn! She got up and started tracking again, this little dog with so much heart. She tracked another 170 yards to the final article, a leather glove. A total of 5 turns and 610 yards, aged almost 3 hours. To actually pass at the NTI is almost too much to hope for, but Lexy did it. I can’t tell you how proud I am of this dog, who never quits and always has my back. And I can’t thank my friend Mary enough, who has been by my side for over 20 years of training together for our 3 generations of tracking dogs. And thank you to AKC Tracking judge and instructor Vincent Ramirez, whose teachings brought us to this level, who gave me the only words of advice I needed for this day - “Team In - Team Out”.
