## Fast CAT<sup>®</sup> Practice – Friday, April 19, 2024, at 5:00-7:00 p.m.

**Pre-Entry Practice Registration – Pre-Entries must be received by Saturday, April 13, 2024. We will accept only 30 paid runs. If runs are available, we will take day-of-practice entries which must be received by 6 p.m. on the day of the practice.**

Nebraska Kennel Club will offer practice runs for dogs on the afternoon before our Fast CAT<sup>®</sup> event. **The pre-entry run fee is \$5 per run. There is a limit of two runs per dog. Day-of-practice run fee is \$10.** Practice will be at H.W. Banner Park, 5005 Virginia Street, Omaha, NE 68157. Dogs do not have to be AKC registered to participate in the practice but they must be at least 1 year old.

**Please make sure you bring along two leashes for your dog and a handler to release your dog!!**
