AKC DELEGATES REPORT

Delegates report from the December quarterly meeting

There were 270 Delegates present for the meeting in Orlando, Florida. There are 500 member clubs within the AKC. 26,000 dog events were held in the year 2023 with 3 million entries for the events. Registration continues to rise.

The amendment regarding a major for Reserve at Specialties passed. All specialties may offer a 3 point major for Reserve Winners.

The new RX program was introduced in the hopes of new puppy owners continuing to register with the AKC. New puppy registrants will receive a gift of some flea/tick treatment and be offered other incentives to continue to individual registration with the AKC.

The Trial Board amendments all passed. They will make it easier and more definitive for events committees to operate when needed. I serve on the Trial Board and think the passage was necessary.

The amendments for not using entire addresses of exhibitors in catalog will be voted on at an upcoming meeting. NKC members has spoken in favor of this change.

Several proposed field trial amendments were introduced. I leave these decisions up to the field trial folk as this club does not really have field trial participants.
