PROGRAM - FETCH – Alycia Noble

Fetch is an AKC Family Dog Program. Pass/fail, noncompetitive test. We will hopefully host an event later in the year. Dogs must be 6 months old or older; registered with AKC. Judges: anyone who is an AKC CGC evaluator can become a Fetch judge. To get a title, dogs must successfully pass the test under two fetch judges. Novice test: 3 retrieves that are at least 30ft. Balls or bumpers. Cannot be a disc or toy with food. Allowed to bring own item or club will provide. Dog needs to bring it within 3-5ft of handler. Intermediate adds more obstacles and must throw farther (50ft). Allowed to use a Chuck-it. Allowed to bring a helper to throw. Advanced: introduces blinds. Must throw 70ft from the start line. 2 single retrieves. 2 double retrieves (two items thrown at the same time). Sent to get one item, retrieves, goes again. Retriever goes from 70ft to 80ft. Does two doubles, one triple retrieve. Ensure that all the toys are behind the blinds.

AKC DELEGATE'S REPORT

AKC Delegate's meeting was held on March 12, 2024 in Newark, NJ. The newly elected directors of AKC are: Carmen Battaglia, Mike Knidght and Sally Finburg.

All proposed amendments passed including the one pertaining to exhibitor's names/addressed in the show catalogs. Adding emails for the exhibitors was not included in the amendment. Many clubs felt that there was too much opportunity for the wrong folk to get hold of exhibitors and use to their advantage.

The AKC Board of Directors was given the Performance Committee's recommendation for an option to the rules of the Detective event. A "fix and go" option to be added if the Board approves. As I understand it, this would help exhibitors to continue if they did not pass. I think that Norine could offer a better presentation here of proposed option to the rules.

The AKC Dog Museum offered a tour of the Museum on Monday eve which was well attended. However, it did cut into committee meeting times on Monday. I have had the opportunity to visit the Museum when it first opened in St. Louis and have since seen the Museumn in NYC. It is very well done and if anyone is in NYC, a visit there is very worthwhile! If you visit the Museum, you may also go to the AKC headquarters as they are in the same building.

By the way, yesterday morning (3/20) Good Morning America had the most popular breed visiting the set. The French Bulldog has now topped the Labrador! (And, I am sure the price was be even higher with the announcement.)

Medora Harper, Delegate

Hello, fellow members. NKC has many new members and I thought it might be of interest to write a message about the position of Delegate.

The American Kennel Club is a club of clubs. There are no individual members. They are based in New York City and in Raleigh, North Carolina. State laws state they must have residency in Newy York and therefore, New York laws apply to the AKC.

Local licensed clubs may become a member of the AKC. The club has to complete several requirements in order to gain membership in the AKC. Only member clubs of the AKC may have a Delegate. Nebraska Kennel Club has been a member club since 1937! Once you are a member club, there is a reduction in fees and the club may offer a second show at no charge. AKC Delegate are the legislative body of the AKC and they pass on all rules pertaining to AKC. Rules may be presented to the Delegate body via Committees, AKC Staff and the Board of Directors of the AKC. There are Delegate meetings held in Newark, NJ, but the December meeting is held in Orlando, Florida. Expense to be a Delegate usually remains up to them, although some clubs pay expenses for the Delegate to attend meetings. All committees are elected within he Delegate body and the Board of Directors are elected within the Delegate body. Staff and Field Representatives, etc. are elected/appointed by the AKC Board of Directors.

NKC has had 5 Delegates over the years. I have held the position longer than anyone. I have been fortunate to hold positions within the Delegate body and have been both Delegate elected and AKC Board appointed to committees. I am responsible for the addition of a ramp for various breeds now used at the dog shows. NKC member President Fred Jaccobberger was Delegate and also served on the AKC Board of Directors. I remember when the first female was elected to the AKC Board of Directors. AKC Board had been traditionally male dominant for many years.

There are several hundred Delegates representing all phases of the sport of dogs. I enjoy being Delegate but have not been as active the past few years. I keep the membership informed of meeting activity. AKC is far more approachable than the early years and offers so much communication to everyone. The AKC website is informative and generally, usable! The staff is willing to reach out and help assist people. The AKC Gazette is online and a great magazine. However, I personally miss not having it in mail versus online. At this clubs 100 anniversary show, we had the AKC booth in attendance. Please take advantage of what t the AKC offers, ask them questions and you should get answers!

I am hoping there will be interest in our membership for members to desire to be a Delegate. It is also necessary to have knowledge of various rules within the AKC. There are many pamphlets available for use. The meetings are on Monday/Tuesday. Committee meetings are on Monday mornings, so there is a bit of time needed to be in attendance. It is a fascinating position and a chance to see how the system works, so to speak. Give it some thought to a new learning experience!!!
