

# September AKC Delegate's Meeting

**S**eptember 20, 2024, The AKC Delegates held their quarterly meeting in Newark, NJ. 286 Delegates were in attendance. President Dennis Sprung called the meeting to order and the election of Standing Committees was held. The regular meeting commenced following the election.

Minutes of the June Delegate meeting were adopted. AKC welcomed the new BIG APPLE Working Group. A moment of silence was held for remembrance of 9/11. The Owner Handler Regional will be held on September24th with more regionals to be held throughout the country.7 more events are planned with the last one to be held in the state of Washington. Another event being held is the National Rally Championship along with an Agility International Event.

Various rules were adopted. All Secretaries and Supt. must adhere to all dog show rules. There are some show who do not use a Supt, but chaired their own events. Vet must examine all dogs who may have been in question by an event committee. Any expenses incurred by an examination is the owners responsibility, not the club.
