The Nebraska Kennel Club needs you and your expert skill to step into the Secretary position! Here are the job requirements as per the NKC Constitution & By Laws for your information.



AKC Delegates Quarterly Meeting

December 13, 2024, the Delegates meeting was held in Orlando, Florida in conjunction with the Royal Canin Dog Show.

The meeting was called to order by President Dennis Sprung. The Nominating Committee presented its slate of 4 for the election of Board of Directors and there are 5 Delegates running by Petition.

Nominating Committee: Tom Davies, Ken Levison, Sylvia Thomas and Harvey Wooding Petition candidates: Carl Ashby, Pat Cruz, Eduardo Fugiwara, Robin Stansell

New Delegates attending their first meeting were introduced. The minutes from the September Delegate meeting were approved as published. Two new member clubs were approved.

A large discussion was held about the decrease in litter and individual dog registrations. Both are down 14% and 17% respectively. There is a new campaign via TV and social media to increase the public knowledge and appreciation of AKC registration. A slide presentation was shown at the meeting but the campaign will begin in February. Many breeders of purebred dogs say there is a lack of interest in future puppies. AKC will be introducing easier methods to register your litter or the individual registrations. Research has found that under the age of 35, very few people have any knowledge of AKC. There were buttons offered at the dog show stating: Declare your Love with the hopes of people realizing the importance of registering your dog, the responsibilities of ownership and the benefit of a purebred dog.

The operating expenses of the AKC are 69 Million Dollars!

A Reserve Best Dog in Show that is a class dog will be awarded the points available within the competition. New Amendments were read to be voted upon at the March meeting. They will be published in two editions of the GAZETTE. One pertains to the disqualification of a dog that has been disqualified 3 previous times by an Event Committee and the other ones is that Brace and Team entries will be allowed at specialties and all breed show which go no further than Best of Breed if they have been spayed or neutered. If approved, it must be listed in the Premium Lists. The Pat Laurans award for "Making a Difference" award was given to four people.
